#### Conclusion

Funds are not sufficient in the fiscal year 2020 budget through fiscal year 2023 budget and financial plan to implement the bill. The bill will cost \$40,000 in fiscal year 2020 and \$281,000 over the financial plan.

#### **Background**

The bill regulates¹ the scope of practice for professional art therapists and graduate professional art therapists in the District of Columbia and establishes qualifications for licensure by the Board of Professional Counseling at the Department of Health (DOH). Art therapy uses therapeutic interventions to assist individuals or groups to improve cognitive and sensory-motor functions, increase self-awareness and self-esteem, cope with grief and traumatic experience, resolve conflicts and distress, and enhance social functioning.

### **Financial Plan Impact**

Funds are not sufficient in the fiscal year 2020 budget through fiscal year 2023 budget and financial plan to implement the bill. The bill will cost \$40,000 in fiscal year 2020 and \$281,000 over the
