#### Conclusion

Funds are not sufficient in the fiscal year 2019 through fiscal year 2023 budget and financial plan to implement the bill. The real property tax abatement will cost \$33,022 in fiscal year 2020 and \$142,329 over the four-year budget and financial plan.

## **Background**

The bill exempts the property at 2714 Georgia Avenue, N.W.<sup>1</sup> from real property taxation beginning October 1, 2019 through September 30, 2029. To maintain the exemption, the property must continue to be owned by Mypheduh Films Inc.2, DBA Sankofa Video and Books, and operate as a video store, bookstore, or cafe. Additionally, at least 51 percent of permanent jobs at the store must be filled by District residents, and 30 percent of those jobs must be reserved for residents of Ward 1. All apprenticeships at the store must be reserved for District residents, with a preference given to Ward 1 residents. The Mayor must certify the property's eligibility annually to the Office of Tax and Revenue.

### **Financial Plan Impact**

Funds are not sufficient in the fiscal year 2019 through fiscal year 2023 budget and financial plan to implement the bill. The real property tax abatement will cost \$33,022 in fiscal year 2020 and \$142,329 over the four-year budget and financial plan.
