Conclusion

Funds are sufficient in the fiscal year 2019 through fiscal year 2023 budget and financial plan to implement the bill. The bill authorizes the Mayor to exercise eminent domain, but does not require the Mayor to act upon the authorization. The fiscal year 2020 through fiscal year 2025 capital improvements plan includes \$12 million to acquire the properties specified in the bill.

Background

The bill authorizes the Mayor to use eminent domain to acquire three privately-owned properties located in the Brentwood neighborhood to be used for storing the equipment, records, property, and supplies of multiple District agencies.¹ The properties are located along Brentwood Road, N.E. and W Street, N.E. where the two roads intersect.²

The Mayor was first authorized to use eminent domain to acquire these properties in 2015³ to facilitate development in the Capital Riverfront neighborhood by relocating DC Water operations to the Brentwood site. The Mayor found an alternate site for DC Water. The Mayor is currently authorized to use eminent domain to acquire these properties for warehousing and storage under temporary legislation.⁴

Financial Plan Impact

Funds are sufficient in the fiscal year 2019 through fiscal year 2023 budget and financial plan to implement the bill. There are no costs associated with giving the Mayor the authority to use eminent domain to acquire these properties.

The tax year 2020 property assessments for the three properties total approximately \$4.9 million. The District will obtain private appraisals for the properties as part of the eminent domain process to determine the ultimate purchase prices, but those appraisals have not been completed. The fiscal year 2020 through fiscal year 2025 capital improvements plan includes \$12 million to acquire the properties if the Mayor chooses to exercise her authority.
