Conclusion

Funds are sufficient in the proposed FY 2009 budget but not sufficient in the proposed FY 2010 through 2012 financial plan to implement the provisions of the proposed approval resolution.

Background

The proposed resolution is allowed in accordance with Section 1(a) of an act that enables the District of Columbia to receive Federal financial assistance under Title XIX of the Social Security Act for a medical assistance program.¹ The Mayor may submit a plan for medical assistance ("State Plan") and modifications thereof to the Secretary of the Department of Health and Human Services. Upon approval, the amendment would allow in year 2 (FY 2009), an inflationary rate increase of 3.2% for services rendered and add 200 participants (150 converting from Intermediate Care Facilities for the Mentally Retarded--ICF/MR--settings and 50 new admissions); year 3, a rate increase of 3% and add 125 participants (100 converting from ICF/MR and 25 new admissions); years 4 and 5, a rate increase of 3% and add 100 and 150 participants all from ICF/MR settings, respectively.

Financial Plan Impact

Funds are sufficient in the proposed FY 2009 budget but not sufficient in the proposed FY 2010 through 2012 financial plan to implement the provisions of the proposed approval resolution.

This fiscal impact statement assumes that any savings realized from the transfer of individuals from ICF/MR settings to the Home and Community-Based Waiver Program will be redirected to the Department of Disability Services from the Department of Heath Care Finance to offset the costs of this expansion. The fiscal impact statement also assumes that any opening created when a consumer vacates an ICF/MR to access services in the waiver program will not be back-filled. The impact on the local fund expenditures outlined below reflects the aforementioned savings in the Department of Health Care Finance.
