Conclusion

Funds are sufficient in the FY 2008 Budget and the proposed FY 2009 – FY 2012 Budget and Financial Plan to implement the provisions of the proposed legislation. The implementation of the proposed legislation does not require additional resources or staff time.

Background

The proposed legislation extends the authority of the Executive Service Compensation System Change and Pay Schedule Temporary Amendment Act of 2007 ("A17-0130"), which added two additional pay scales, E6 and E7, to the executive level schedule (Table 1). The proposed legislation also authorizes the Mayor to establish the salary for Allen Lew, the Director of the Office of Public Education Facilities Modernization, upon the expiration of A17-013 on July 6, 2008, without Council approval.
