Conclusion

Funds are not sufficient in the fiscal year 2026 through fiscal year 2029 budget and financial plan to implement the bill. The bill's implementation will cost \$132,000 in fiscal year 2026 and \$545,000 over the four-year financial plan period.

Background

The District has several climate and energy-related initiatives, including measuring the energy use at public and private buildings, supporting a Commission on Climate Change and Resiliency,1 and reducing greenhouse gas emissions. The bill establishes a seventeen-member Youth Advisory on Climate Change and Environmental Conservation (Youth Climate Council) to further these efforts.

The Youth Climate Council will provide recommendations to improve the District's laws, policies, practices, and budgets that support climate change mitigation, environmental conservation, and the green workforce. The bill provides that the Mayor and each ward councilmember should appoint the members and establishes who is eligible to be a member,² the length of terms on the Youth Climate Council, and how the Youth Climate Council should function. The appointments must be made within 180 days of the bill's effective date. The bill authorizes the District to compensate members with a

stipend of up to \$1,000 annually or the certification of service hours, and approval to receive academic credit if authorized by the individual's school. The Department of Energy and Environment (DOEE) may also reimburse members for any expenses incurred in the performance of their duties if funding is available.

The bill requires DOEE to provide training to Youth Climate Council members within sixty days of their appointment. The training should cover government and political processes and structures, the current environmental policy landscape, the Youth Climate Council's statutory mandates, and open government procedures. DOEE should assist the Youth Climate Council in organizing its meetings, connecting with other District agencies, and developing any reports or presentations. DOEE should also help the Youth Climate Council provide commentary on legislation and make presentations to the relevant Council committees.

Financial Plan Impact

Funds are not sufficient in the fiscal year 2026 through fiscal year 2029 budget and financial plan to implement the bill. The bill's implementation will cost \$132,000 in fiscal year 2026 and \$545,000 over the four-year financial plan period.

The bill requires DOEE to support the Youth Climate Council through training, facilitating interagency coordination, and stipends. DOEE's experience supporting similar activities, such as the Commission on Climate Change and Resiliency, indicates a need for one full-time staff to support the Youth Climate Council and ensure its successful implementation. The DOEE staff will cost \$115,000 in fiscal year 2026 and \$477,000 over the four-year financial plan period. DOEE also requires \$17,000 annually to support the \$1,000 annual stipend for each selected member.
