#### Conclusion

Funds are not sufficient in the fiscal year 2023 through fiscal year 2026 budget and financial plan to implement the bill. The bill will cost \$2.3 million is fiscal year 2023 and a total of \$7.1 million over the four-year financial plan.

# **Background**

The bill requires the District government or entities leasing space in District-government-owned buildings to install a dispenser for period products in all women's and gender-neutral bathrooms, or if gender-neutral bathrooms are not available, at least one men's bathroom per building. Entities operating human care agreements with the District are also covered by the bill's mandate. Entities responsible for the maintenance of such restrooms must also stock the dispensers with sufficient products to serve all building visitors, and the products shall be free of charge.

## **Financial Plan Impact**

Funds are not sufficient in the fiscal year 2023 through fiscal year 2026 budget and financial plan to implement the bill. The bill will cost \$2.3 million is fiscal year 2023 and a total of \$7.1 million over the four-year financial plan.

The Department of General Services estimates that it will need to install and keep stocked about 1,327 dispensers in District-government-owned buildings. The estimate includes buildings operated by the Department of Human Services and is assumed to encompass the human care agreement mandate. The estimate excludes school buildings, which were previously mandated to provide period products under separate legislation<sup>1</sup>.
