### **Conclusion**

Funds are sufficient in the fiscal year 2017 through fiscal year 2020 budget and financial plan to implement the bill.

## **Background**

The bill prohibits¹ the use of tobacco products² at all times in the entire physical area of a site that is designed for hosting organized sporting events,³ including all open, semi-open, and enclosed spaces and structures within the site. The owner, lessee, manager, operator, or person in charge of the event site is required to display signs stating "No use of Tobacco Products." These signs must be visible to the public at every entrance to the sporting event site as well as all dugouts, bullpens, training rooms, locker rooms, team bench areas, spectator seating areas, bathrooms, press boxes, vendor areas, and television and radio broadcast booths. The bill also updates violation penalties to include athletic events sites and bans the defacing or removal of a "No Use of Tobacco Products" sign.
